## A Masonic Minute

A Masonic Parable

"Christmas time! That man must be a misanthrope indeed, in whose breast something like a jovial feeling is not roused— in whose mind some pleasant associations are not awakened— by the recurrence of Christmas." — Charles Dickens (1812-1870).

What was to become the best loved Christmas story in the English language was penned by Charles Dickens in 1843 and published in London on December 19th of that year. Although classified as a novella, it is in reality a powerful morality play. As such it has been staged and filmed countless times. The quintessential filmed version starred Alistair Sim as *Ebenezer Scrooge* (1951). A CHRISTMAS CAROL has never been out-of-print and is available today. Charles Dickens is regarded as the greatest novelist of the Victorian period.

At the outset, Scrooge is portrayed as a cold-hearted, self-centered shrewd and demanding money-lender that despises the frivolity of Christmas. "Bah, humbug!" He lives alone and is the surviving partner of the London firm of Marley and Scrooge. It is Christmas Eve. After grudgingly allowing his clerk, Bob Cratchit, the day off for Christmas, Scrooge returns home and retires to bed where he is visited by several 'spirits' – Jacob Marley, his long dead partner, and the three Ghosts of Christmas (Ghost of Christmas Past, Ghost of Christmas Present, and Ghost of Christmas Yet to Come.) When Scrooge awakes on Christmas morning, he immediately repents and becomes a model of generosity and kindness. A new man, he enters cheerfully into the spirit of the day. Henceforth, "it was always said of him that he knew how to keep Christmas well if any man alive possessed the knowledge."

Dickens portrays a penetrating exercise in self-examination for Scrooge which results in a transformation of his character from a miser who cares only about himself and the accumulation of wealth to a man who genuinely cares about others.

Freemasonry enables us to see things in a new light, to see things from a new perspective through new eyes. As Freemasons trained to think in terms of allegories and symbols, *A Christmas Carol* resonates with Masonic correlations. Our three degrees in Craft Masonry, simplified as birth, life, and death, correspond to the three Ghosts of Christmas. As an initiatory Order, we also endeavour to transform ourselves by self-examination and 'a well-regulated course of self-discipline.' Like the transformed Scrooge, we endeavour to be happy ourselves and communicate that happiness to others.

Although Charles Dickens was not a Freemason, I suggest that *A Christmas Carol* may be interpreted as an instructive Masonic Parable. It is a vivid portrayal of the transforming effect of initiation. As such Dickens captures the essence of Freemasonry.

## International Order of the Rainbow for Girls



#### Who are we?

The International Order of the Rainbow for Girls (Rainbow Girls or Rainbow) was created in 1922. Rainbow's members are girls aged 11-

21. We also run "Pledge Sisters" in some areas for 7-10 year old girls. Girls don't need to be affiliated with the masonic family in order to be members, although many are.

#### Where are we?

There are currently more than 850 Assemblies across the world with 6 here in Canada. Local groups meet in Windsor, Burlington, Brampton, Ajax, Port Hope and Ottawa.

#### What do we do?

Service and Responsibility:

Rainbow's main goal is to be of service every day and to do charity work in our communities. At a local level, the girls choose a charity to support each term and either raise funds, volunteer their time or both. Our Assemblies also participate in local charitable ventures such as donating to families at Christmas or collecting for food banks/women's shelters among others.

Nationally, the Grand Assembly of Canada's charity is "Pearls for Girls", an organization that sells jewellery to support leadership training for girls in Lesotho. We make and sell pearl bracelets to support this charity.

We also fundraise for the expenses of running an Assembly. Many of our Assemblies pay rent and insurance at the halls where they meet, some subsidize activities for the girls, and all pay per-capita amounts to our governing bodies and buy regalia.

You may see the girls at your Lodges selling chocolates, raffle tickets, or other fundraising items. They're there learning about service to their community and responsibility by helping to raise funds for charities or to support the local Assembly.

#### Leadership:

In doing this work, Rainbow teaches leadership. The group is run by the girls. Rainbow has various stations that the girls rotate through, moving their way up if they choose to the top station in a local group, that of Worthy Advisor. The Worthy Advisor comes up with agendas for the meetings, picks a theme and charity for the term, and runs all meetings.

While there are adult advisors there to help guide and ensure everything goes as planned, the girls are responsible for planning all events, from coming up with the idea to fundraising if needed to the execution.

Our girls also have the chance to become Grand Officers at the national level. These girls serve as examples to their peers and travel representing the Grand Assembly of Canada. The highest station at this level is that of the Grand Worthy Advisor, who is elected to serve this station for a one year term.

Public Speaking

Like the Masons, Rainbow Girls participate in Ritualistic

work that they are required to memorize and present in front of a crowd. They also prepare and present speeches about Rainbow to deliver at larger events. We'd encourage you to contact your local Assembly to either attend a meeting or to invite them to do a presentation at your next Lodge meeting – they'll be happy to present a ceremony or presentation about our order.

#### Travel

The Grand Assembly of Canada has three major events each year: A Grand Officers' Reception in the fall, Grandy Camp in May, and Grand Assembly in August. In addition to attending these events, our members have the chance to visit other Assemblies and to make friends from all over. For the past several years, Grandy Camp has been completely subsidized by a generous donation from the Masonic Foundation of Ontario

Girls can also travel to other jurisdictions, or attend Supreme Assembly which is held every two years. It's always neat to hear about Rainbow Girls from other countries, and many of our girls have friendships with members they've met by travelling.

#### Fun

What ties all of these activities and lessons together is FUN. Even while serving at a dinner, manning a table at a fundraiser or driving hours to attend an event, our members always find a way to make it fun. Ask any Rainbow Girl and they'll tell you that one of the best parts of Rainbow is the chance to get to know other girls of different ages, backgrounds, and to spend time with friends. Many of our advisors are past members, and what keeps them coming back year after year are the bonds they've made with others over the years.

## Order of the Amaranth

The Order of the Amaranth is a fraternal and charitable organization whose

membership of men and women with masonic affiliation share in social activities to promote the growth of our Order. Although a belief in the existence of a Supreme Being is foremost to being a member, we welcome many faiths represented within our membership. Our ritual is an integral part of our Order and emphasizes the values of everyday life, founded on the sublime teachings of Truth, Faith, Wisdom, and Charity. It is by these teachings we strive for our own self-

satisfaction and improvement while working with those who are in need of our help and assistance.

Our history dates back to 1653, when Queen Christina of Sweden created an Order for her court of knights and ladies. In 1860, James B. Taylor of Newark, New Jersey drew upon Queen Christina's order to create a new fraternal society. In 1873, Robert Macoy organized Taylor's society into the Order of the Amaranth, part of a proposed Adoptive Rite of Masonry. Eastern Star was to be the first degree, and until 1921, all Amaranth members were required to join Eastern Star first.

In our teachings, members are reminded of their duties to God, to their country and to their fellow beings. They are urged to portray by precept and example their belief in the "Golden Rule" and by conforming to the virtues inherent in Truth, Faith, Wisdom, and Charity. We are an international order with the Supreme Council, Order of the Amaranth Inc., having jurisdiction over Subordinate Courts in their area. There are Grand Courts in Canada, the United States, Australia, Scotland and the Philippines. Subordinate Courts also exist in areas that have no Grand Court, and are directly under the supervision of Supreme Council.

Our primary philanthropic project is for Diabetic Research. In Canada, we contribute to the Charles H. Best Foundation. The U.S. Contribute toward the Amaranth Diabetic Foundation, which has contributed a total of \$14.0 million dollars to the American Diabetes Association, Research Foundation. All money not raised in the U.S., Goes toward Diabetic Research with in the country it was raised.

We have 23 officers, with the Royal Matron serving as the presiding officer, and assisted by the Royal Patron. Our meetings are formal, with the ladies required to wear long gowns and gloves. The Royal Matron, wears a crown.

As stated, all women must have Masonic affiliation to join, or attend our meetings. But any Master Mason is welcome to attend, after having taken an oath of Obligation at their first meeting. They remain our welcomed guests until, such a time as they are willing to join into full membership.

Our Court, Queen Anne #3, meets at Dufferin Lodge, 200 Highway 8, West Flamborough, Ontario. We meet on the third Friday of the month. S.K. Kris, and I would like to invite you to attend any of our meetings. We have our social time before the meeting, enjoying a meal together. A nominal fee of \$7.50 is requested if attending the dinner. (R.S.V.P.)

## Masonry and C.G. Jung The Symbolic File Article #5:

In the previous article the work of Dr. C.G. (Carl) Jung is stated to be of great value in understanding the symbolism and purpose of Masonry. He was one of the fathers of modern psychology and a great researcher and thinker.

I consider Dr. Jung's work of more value to Masonry than that of Sigmund Freud. One of the reasons is that his symbolism is much more extensive than that of Freud and relates closer to Masonry. The symbolism of Masonry is so extensive that, as stated earlier, Dr. Jung's work can only give a "foothold" on which to move forward.

In order to set a course from that "foothold" outlining some of Jung's terms and aligning them with references from Masonry may prove to be of some help Science today has proven Jung's theory correct that man is made up of two aspects. Both Jung and science call them the Conscious and the Unconscious. In Masonry these two aspects are often referred to as the Outer Man (the Conscious Aspect) and the Inner Man (the Unconscious Aspect).

In the Lodge there is an axis line running from east to west. This divides the Lodge north to south. The south side of the Lodge represents the Conscious Aspect or the Outer Man. The north side of the Lodge represents the Unconscious Aspect or Inner Man. Jung also refers to what is called the "Centre of Self". A Mason would understand the importance of the term "Centre" since the Lodge is opened in the Third Degree "on the Centre". There are other aspects outlined by Jung and shown in the symbolism not discussed here. Jung calls the combination of all the aspects of man the "Self".

To use a computer term, I call the axis line running from east to west, which divides the Lodge north to south, the "Firewall". The Firewall separates the Conscious from the Unconscious. This divide is much spoken of in literature and is often the subject in art. Masonry is viewed completely from the Outer Man or the Conscious side. All the symbols or "answers" are given to a Mason through the various degrees. It is only necessary to "Speculate" on their meaning. It is not necessary to seek them out for ones self since all the hard work has been done for him.

The reason the Firewall is necessary is that it keeps a complete separation between the Inner Man and the Outer Man. This allows the Outer Man, the Conscious aspect, to function with what is called "Freewill" and make rational decisions on its own. Although he has Freewill, man makes his decisions in conjunction with the "Law" and from moral guidelines, although when watching the news today it is clear that this is not always the case. It is up to Masons to steady the ship on its course and lead by example. Much can be researched on how the two aspects of man function.

They are however much like two computer operating systems that do not talk to one another. The Outer Man, the Conscious Aspect, functions by way of the five senses under the light of the physical sun (in the south) The Inner Man, the Unconscious Aspect, functions in darkness only by way of symbols (in the

north). In order to bring the two aspects together the Outer Man must understand the symbols. Masonry provides both the symbols and the tools to understand them. The knowledge of the symbols of the Inner Man allows a Mason to understand his entire makeup or what Jung calls the "Self". This is the "Self" in the term "Know thy Self" Dr. Jung provides a system to comprehend the symbols of the Inner Man. In turn this system provides a "Process" for a Mason or any individual on the Path to understand themselves. Masonry however is much, much broader than that of modern psychology. It is "Ancient" and not only allows a man to understand himself but also "the hidden mysteries of nature and of science".
