Housekeeping Items:

As some messages seem to need repeating time and again, I would ask for your support with the following matters:

- (1) Ontario Mason Magazine: A reminder that if Brethren in your District did not receive a copy, it is probably because we did not receive their address. If the message did not get through you to the Lodge Secretaries or the Lodge Secretaries did not respond, then no copies were mailed to the Brethren in the Lodge. A very limited number of copies remain in the office, but may only be secured by having the Lodge Secretary contact the office. Postage will be charged to the Lodge semi-annual return. Copies may also be picked up in person at the Grand Lodge office.
- (2) Square and Compasses: Any Grand Lodge publication, any District Newsletters, any websites, lodge signage, etc. in this jurisdiction should be using the authorized version of the Square and Compasses logo as found in the Book of Constitution, Section 3.1. Electronic versions are available on the CD distributed to each D.D.G.M. at the Regional meetings last August or on the Grand Lodge website.

Looking Ahead:

As we look ahead to the New Year, I wanted to emphasize again the importance of Communication and Masonic Education, two of our top priorities. I encourage the Masters of the District Lodges to elevate the importance of Masonic Education in their agendas. I still see many comments in the Lodge Summons stating that we had a great piece of education last month – when the candidate was unable to be present, when our plans changed, etc. – as though the education was the afterthought. Lodge or District Lodges of Discussion are an extremely useful educational tool that can effectively engage newer and experienced members. Why not ask one of your newer Masons to plan and execute one? Assistance is always available from the Grand Lodge, Lodge Resources Committee.

Grand Lodge continues to push ahead with its primary communication tool. I have been eagerly watching the development of our new website and Team Leader, Richard Kaufman indicates that Phase 1 will be ready for implementation early in the New Year.

This month I hope, with the assistance of the D.D.G.M.s, to stimulate an interest in those Lodges that may not think they have a stepping stone, or a trigger to Ensuring the Timeless Vitality of Freemasonry in their Lodge. The spark that lights the fire again, may be at the very doorstep of the Lodge.

A meaningful communication to all Lodge members from the Worshipful Master or a single bit of education that has a 'Wow' factor may be the trigger you need. FROM THE DEPUTY GRAND MASTER

Brock University Partnership:

The partnership established between the **Grand Lodge and Brock University** has proven most productive and mutually beneficial to both educational institutions. Its beginning was with the initiative of the Heritage Lodge to support and maintain the Masonic collection in the James A. Gibson Library, and continuing with the posting on line of the Proceedings of Grand Lodge from 1855 to 2010.

The Annual **Dr. Charles A. Sankey Lecture in Masonic Studies**, funded by the College of Freemasonry, is now in its third year with **Dr. Steven C. Bullock** from the Worcester Polytechnic Institute. His topic is *The Heart of Masonry: Upstate New York and the New Nation, 1776–1826*, and is being presented on **Sunday, May 6, 2012**.

The first phase is culminating in the joint sponsorship of the International Conference on the History of Freemasonry in 2015 supported by contributions to the Grand Master's Project (Foundation Project Number 2937.) The study of fraternalism in general and Freemasonry in particular has been advanced significantly.

The second phase of the mandate of the Partnership states: "To establish an endowment fund in conjunction with Brock University to financially assist in the study of Masonry." We cannot leave it to the conspiracy theorists and the lunatic fringe to project our public image. To gain academic credibility as an institution that has had a significant impact on the shaping of Canadian society over the last three centuries would do much to restore the respect which the Craft once enjoyed.

Brethren wishing to contribute to this phase of the partnership may do so through the Masonic Foundation of Ontario Project No. 2937 – The Brock University Partnership. All contributions are tax deductible.

The Niagara region was the cradle of early Canadian history and the birthplace of Freemasonry in Upper Canada and the home of our senior lodge in the jurisdiction, Niagara No. 2. The forthcoming celebration of the bicentenary of the War of 1812 will focus much attention on the history of Upper Canada. Major-General Sir Isaac Brock, the intrepid hero of that war, was a Freemason.

The vast collection of research material available in the collections of Dr. Charles A. Sankey, J. Lawrence Runnalls, and others made Brock University the logical location for this Centre for Masonic Studies.

Lodge Resources – The Cornerstone Project:

The primary purpose of the Cornerstone Project is to encourage and recognize lodges that plan, implement and manage a well rounded yearly lodge program that promotes lodge activities, brotherhood, charitable work and involvement in the community. The Cornerstone Project is **not** a competition between lodges.

I would suggest if you want to improve the Condition of Masonry in your lodge, look at implementing a Cornerstone Program that meets your needs. When a lodge makes the decision to participate in this program they demonstrate their desire to increase the value of the experience it provides to the membership.

Participation will bring many value added benefits. The Cornerstone manual can be downloaded from the Grand Lodge Website Home Page – Latest Update Links. Take the time and get involved to improve the Condition of Masonry in your lodge.



The Heart of Masonry: Upstate New York and the New Nation, 1776-1826.



NO TIME WASTED IN LODGE

Some of the best initiatives come from the grass roots - from Districts, Lodges or individual Masons. Here is something developed in Wellington District that is awesome in its elegance. The equipment consists of three Masonic Apron Graphics one of which is shown below.



I suggest you create copies of this, adapt it for other degrees (Fellow Craft or Master Masons: to be used during time in the ante-room while temporarily absent from Lodge e.g. at installations) and hang one on a hook in the anteroom of your lodge. Then arrange for the brethren to use them: Our newest Masons are the most curious, most interested, most easily instructed members we have. At the same time that they are seeking their own understanding of our curious institution, we are at greatest risk of losing their interest. If you can, recall the feeling you most likely had during your degree progress, when you were told perhaps for several months running, that you were to sit outside the lodge while another member received his next degree.

We must better employ the time of our newest Masons. There should be no wasted evenings at lodge. New members are understandably impatient to progress. They need to learn that we care about their progress and that we are committed to their advancement.

This is a simple plan, and is well within the capabilities of every lodge to employ. On every degree-planning sheet, the Master should designate the appropriate chairman, or a well-skilled member to retire with those members who are being excused for a time, and to ensure that good use is made of that "teachable moment". It may be necessary in a very busy lodge to run anteroom sessions for several meetings in succession with the same new Mason, or group of Masons.

This is an unprecedented opportunity to enhance knowledge. It is player development: team building, expert coaching, practically on a one-to-one basis. The topics suggested for presentation are starting points. I encourage you to be thorough and creative. Team-teaching is appropriate. Have the material for the evening prepared. Let your newest Masons know that there will be something for them at lodge this

month. (A phone call or e-mail contact would encourage their attendance and participation.)

Take whatever time this initiative requires in your own lodge situation and use whatever techniques you find appropriate. Let your DDGM know about your successes and share your best presentations.

ANCIENT CHARGES OF 1723

IV: Of Masters, Wardens, Fellows and Apprentices

"All preferment among Masons is grounded upon real Worth and personal Merit only; that so the Lords may be well served, the Brethren not put to Shame, nor the Royal Craft despis'd: Therefore no Master or Warden is chosen by Seniority, but for his Merit.

It is impossible to describe these things in Writing, and every Brother must attend in his Place, and learn them in a Way peculiar to this Fraternity: Only Candidates may know that no Master should take an Apprentice unless he has Sufficient Employment for him, and unless he be a perfect Youth having no Maim or Defects in his Body that may render him uncapable of learning the Art of serving his Master's Lord, and of being made a Brother, and then a Fellow-Craft in due Time, even after he has served such a Term of Years as the Custom of the Country directs; and that he should be descended of honest Parents; that so, when otherwise qualifi'd he may arrive to the Honour of being the Warden, and then the Master of the Lodge, the Grand Warden, and at length the Grand Master of all the Lodges, according to his Merit.

No Brother can be a Warden until he has pass'd the part of a Fellow-Craft; nor a Master until he has acted as a Warden, nor Grand Warden until he has been Master of a Lodge, nor Grand Master unless he has been a Fellow Craft before his Election, who is also to be nobly born, or a Gentleman of the best Fashion, or some eminent Scholar, or some curious Architect, or other Artist, descended of honest Parents, and who is of similar great Merit in the Opinion of the Lodges.

These Rulers and Governors, supreme and subordinate, of the ancient Lodge, are to be obey'd in their respective Stations by all the Brethren, according to the old Charges and Regulations, with all Humility, Reverence, Love and Alacrity."

THE FOUR CROWNED ONES







Did the Four Crowned Ones ever live? Were they martyred? Were they stonemasons in our sense of the word, or artists, carvers in precious metals? To answer one needs to be wise enough to untangle fact from fancy. It is the history of all legends of which the sources are lost in the mists of time, that passing the story from tongue to tongue, year by year, century to century, often confuses the original facts until the student has a hard time digging down through this literary patina of the ages to the hard metal of truth beneath!

However, the legends of the Four Crowned Ones - for there are more than one - are not dependent on one source alone for the telling. Several Latin and Greek manuscripts; and at least eight histories of martyrs, ranging in date from A.D. 400 to A.D. 894, tell the tale - or tales. Then there are the Brevieries, principal among which is that of Rome, dated 1477, but evidently compiled from earlier sources.

All record different versions of two distinct stories which in the course of time, have been confused, interwoven, merged, disentangled, again mixed. In brief, four officers of the Roman Army were executed, and five sculptors, artists or stonemasons, were martyred, all for their faith in Christianity. The murderer was the Emperor Diocletian. The names of the five artists were in time forgotten; it was then ordered that all nine should be commemorated under the title Four Crowned (or Holy) Martyrs. Later the missing names were recovered, but by this time, a church having been consecrated to the Four Crowned Ones, and years having passed, the pleasant fiction was continued and the Nine are still the Four! Thus, in all strangeness, four soldiers of Rome became the patron saints of early builders, instead of the five sculptors who should have been, although their trade or profession persisted under the names of the four!

The four were secretly Christians and they converted Simplicious to that faith; and this was an evil age for the followers of the Carpenter of Nazareth.

The Emperior Diocletian, worshiping the gods of his day and age, commanded the five to carve him a statute of the god Aesculapius. When they repeatedly refused, the angry Emperor had them first scourged, them immured alive in sealed coffins and cast into the river. Later, one Nicodemus, a Christian, raised the coffins.

Two years later four officers of the army, by name Severus, Severianus, Carpophorus and Victorinus, refused to worship Rome's idols and false gods. Again by order of Diocletian they were beaten to death with whips armed with lead balls, and their bodies thrown into the streets for the dogs, where they lay five days. The names of these soldiers who died for their faith were lost for many years; then (according to

legend), they were recovered by a direct revelation from Heaven.

These two legends, two sets of martyrs, and two dates of martyrdom, in time became confused one with the other. Sometimes it is the four soldiers who were artists and cast into the river in coffins, sometimes it is the five who suffer death by whipping. Sometimes they die on the same day, sometimes eleven months, again two years apart. Sometimes it is five, then it is four, who first suffer. In one version, one set of names is lost; in another the second set is recovered by a revelation from heaven. What's common and agreed upon in almost all accounts is that nine men were put to violent deaths for faith in Christ and refusal to worship images, that their names were lost and recovered, and that all, by order of Pope Melchiades (A.D. 310) became known as the Four Crowned Ones.

The Craft has commemorated the Four Crowned Ones in a way known to all students; the great Research Lodge in London, Quatuor Coronati, is named in their honor. It carries a good little picture, or sketch of the Four Crowned Ones, taken from a decoration or illumination of a page in the Isabella Missal (dated about 1497), on the first page of all its monumental Transactions (now in their forty sixth year). The Lodge published, as the first of its priceless reproductions of old Masonic documents, the Regius Poem which connects the Four Crowned Ones directly with Masonry.

From very early days, the Four Crowned Ones became the patron saints of builders, first in Italy, later in Germany and elsewhere. Statues of the Martyrs were placed in niches in churches, as in the exterior of the northern wall of the Church or San Michele, church of the trade guilds of Florence.

The German Constitutions of Strassburg (1459) open as follows: "In the name of the Father, and of the Son, and of the Holy Ghost, and of our gracious mother Mary, and also of her blessed Servants, the Crowned Martyrs of everlasting memory." Flemish Guilds of operative Masons were known as Vier Ghecroonde or Quatuor Coronati. In A.D. 619, a church is Canterbury was dedicated to the Four Crowned Martyrs. As late as 1481 an Article for the regulation of craftsmen in London (Masons Company) reads: "That every freeman of the Craft shall attend Christian church (within Aldgate) on the Feast of Quatuor Coronati, to hear Mass, under penalty of 12 pence.'

Why did the Four Crowned Ones, (whether four, or five, or nine) at once, seemingly, become famous in the annals of craftsmen? During the early centuries a succession of cruel men ruled in Rome: Christians were persecuted, burned, thrown to the lions, tortured, martyred. A noble company and large - why should these four (or five or nine) have been celebrated in Roman church, in story, song, missal, brevity, statue and legend, above others equally as deserving, equally as brave, equal in suffering and death?

No certain answer can be given. But it seems a reasonable guess that Christianity, starting among the poor and lowly, the "underprivileged" as we should call them, spread much more rapidly among the humble than among the patrician. The guilds of workmen, the collegia of Rome, the associations of workers, would normally become Christians far sooner than the rulers, the nobles, the patricians, the wealthy class. It is universal in history that the stronger the persecution, the greater becomes the strength of associations and the more tenaciously they hold to the bond which unites them.

If the four (or five, or nine) who died for their faith were members of the craftsmen's guild or collegia, their fellows would at once think of them as heroes; not only as men who died for their faith, but as craftsmen who upheld the honour and dignity of their order.
