FROM THE GRAND MASTER



D.D.G.M. Correspondence Course: At our mid-term meetings, we again stressed the need to ensure that each District has one or more Brethren enrolled in or already having completed the D.D.G.M. course. We requested that if you know the names of potential candidates for the office in your District for July 2012, that you forward them along to the Deputy Grand Master. This is the only way that we can monitor the progress of

candidates for the Office and know the District will have a successor. From what I have seen to date, we have very few Districts with candidates who will be qualified.

Grand Lodge Website: By now you should have received the announcement for the new Grand Lodge website. (See page 3 of this issue for the announcement). Allow me to congratulate R.W. Bro. Richard Kaufman, Team Leader, R.W. Bro. Norm McCarthy, Chairman, all the members of the Committee and our Partners at Imagination Plus, who helped to make this possible.

Looking Ahead: One of the questions posed in last year's Grand Lodge survey was, "Does Your Lodge Do Enough To Retain Quality Members?" The percentage of responses were: Yes – 44%; No – 40.3%; Not Sure – 15%. Think about the implications. In the eyes of the respondents, only 44% of the Lodges are doing enough to retain quality members. In Ontario last year, we initiated approximately 1500 new Masons. Could that mean that we are at risk of losing 660 of those men because we aren't going to meet their expectations?

Several of the strategic goals in our long range plan address the issue of new member expectations. I draw your attention to two of them: (1) To better understand, serve and support the needs of our current members and their families. (2) To create high quality educational programs and training courses for all Brethren in the jurisdiction.

Our Grand Lodge working plan for this year contains several initiatives which address these goals. First, the survey itself provided insight into our members' expectations and needs. We are using the survey results as input to our strategic planning for 2012 – 2013. The continuing efforts of our Protocol and Etiquette team and several new initiatives of the Masonic Education Committee, including the renewal of the Monthly Bulletin, the Masonic Conference planned for Ottawa in June and a proposal to expand our College offerings, all address the need for making high quality education available to our members.

During 2012, we commemorate the bicentenary of the War of 1812, in which Freemasons played a prominent part. Our third Sankey lecture scheduled for May 6, 2012, will provide us another rare opportunity to learn much about Freemasonry during this time.

And finally, our new website and other communication initiatives are all designed to open up our communication channels to the Brethren and enable the delivery of a great deal more information timely and effectively.

And so, we come full circle back to the key focal points of your Grand Lodge for his year – communication, education and understanding of the real condition of Masonry (the expectations) in our Lodges. Your Grand Lodge continues to do its part to provide opportunities for our new members to meet their expectations.

Last month I spoke of *Vitality* and how it impacts viability. The *Vitality* we bring to the Craft as Grand Lodge Leaders, District Leaders and Lodge Leaders, will go a long way to stimulating the spirit necessary to motivate our **existing members** so they take up the challenge. And **that challenge is** – further our own self-improvement as we engage our new Masons in the satisfaction of their expectations.

"Ensuring The Timeless Vitality of Freemasonry".

Believe in it. Believe me when I say – Your enthusiasm and vitality will determine the Masonic future of the men we are initiating today. **Make it** happen!

Should any lodge refuse or neglect to make that required returns and payments he shall immediately report the fact in writing to the Grand Master."

We will achieve that Vision by creating a website environment that delivers high quality, relevant, up-to-date content to all Grand Lodge constituents, in a phased implementation.

Phase One delivers the underlying foundation for our website of the future, but the content of Phase One is limited. Phase One presents the public face of our new website and its content is geared to the general public (non-mason), the Mason who wishes to learn more about Freemasonry in Ontario and anyone wishing to locate and visit a lodge in our jurisdiction. The new Lodge Locator is a key component of Phase One.

Phase Two provides us the opportunity to organize and reorganize our content to improve the navigation of our website. The lodge locator application will be enhanced to return "proximity" locations to your search as well as meeting date information.

ANCIENT CHARGES OF 1723

VI. Of BEHAVIOUR.

1. "In the LODGE while CONSTITUTED. You are not to hold private Committees, or separate Conversation without Leave from the Master, nor to talk of anything impertinent or unseemly, nor interrupt the Master or Wardens, or any Brother speaking to the Master: Nor behave yourself ludicrously or jestingly while the Lodge is engaged in what is serious and solemn; nor use any unbecoming Language upon any Pretense whatsoever; but to pay due Reverence to your Master, Wardens, and Fellows, and put them to Worship.

If any Complaint be brought, the Brother found guilty shall stand to the Award and Determination of the Lodge, who are the proper and competent Judges of all such Controversies (unless you carry it by Appeal to the Grand Lodge), and to whom they ought to be referr'd, unless a Lord's Work be hinder'd the meanwhile, in which Case a particular Reference may be made; but you must never go to Law about what concerneth Masonry, without an absolute necessity apparent to the Lodge.

2. BEHAVIOUR after the LODGE is over and the BRETHREN not GONE

You may enjoy yourself with innocent Mirth, treating one another according to Ability, but avoiding all Excess, or forcing any Brother to eat or drink beyond his Inclination, or hindering him from going when his Occasions call him, or doing or saying anything offensive, or that may forbid an easy and free Conversation, for that would blast our Harmony, and defeat our laudable Purposes. Therefore no private Piques or Quarrels must be brought within the Door of the Lodge, far less any Quarrels about Religion, or Nations, or State Policy, we being only, as Masons, of the Universal Religion above mention'd, we are also of all Nations, Tongues, Kindreds, and Languages, and are resolv'd against all Politics, as what never yet conduct'd to the Welfare of the Lodge, nor ever will."

THE WORKING TOOLS OF A CANADIAN MASON

The Working Tools of a Canadian Mason are the snow brush, the common shovel, and the hockey stick. The snowbrush is the first implement put into the hands of the Canadian, in order to brush the snow off his vehicle and to scrape the ice off his windshield. The shovel is used to move snow off the driveway and sidewalk and throw it into heaping piles on the lawn so you can drive your vehicle in and out of the garage; the hockey stick is to play hockey with friends and family on your nicely shaved driveway, or on the street in your neighbourhood in the cold snowy weather. Your choice, really.

But as we are not American, but rather freezing and freaking cold Canadian Masons, we apply these tools to our morals, eh? In this sense, from the snow brush we learn a daily lesson of accumulation and instruction, for as it is divided into two parts, it recalls our minds the division of the year into two seasons – construction and winter – and directs us to apportion them to their proper objects, namely golfing and skiing.

From the common shovel we learn that bad backs are more prominent than we thought; for the heart may stop and the head-cold throb with pain if the hand be not prompt to lift the snow.

From the hockey stick we learn that perspiration is necessary to establish hypothermia, that the icy material receives its slippery finish from repeated melting and freezing alone. That nothing short of inflatable exertion can induce the habit of puck handling, enlighten your behind, and render the goals pure.

From the snow we deduce this moral; that igloos, grounded on accuracy, aided by seal skin and prevented by collapse will finally overcome all wind chill factors, raise the body temperature from despair and establish happiness in the paths of clear, sunny skies.
