## FROM THE GRAND MASTER

Brethren:

There are several issues which I wish to bring to your attention at this time.

1. District Events: Many of you have been using the services of our Internal Communications team under the leadership of W. Bro. Eric Lakien to distribute news of your District events. Receptions, and several Lodge Anniversaries, visits, etc., must be sent to the Grand Lodge Office for review prior to distribution. Please ensure that the Grand Secretary has approved your material before sending to Eric for distribution. Eric provides us with a great service, BUT it is up to each of us to ensure the quality and accuracy of the material we ask him to send out.



2. Use of Electronic Devices: We are getting more and more interruptions due to cell phones ringing and Brethren utilizing their electronic devices for texting and communicating while in Lodge. I have spoken with R.W. Bro. Gordon Crutcher, the Chairman of the Protocol and Etiquette Committee and the current issue of P & E Essentials addresses this issue. ### Looking Ahead:

We are eagerly looking forward to the spring season of banquets and visitations. What a privilege and honour to be able to meet with so many of you around the jurisdiction. Each time we are out, we are greeted

## FROM THE DEPUTY GRAND MASTER

Thinking about serving our membership at Grand Lodge? Grand Lodge is seeking qualified, motivated and active Past Masters, who believe in our Mission: “to provide effective and sustainable leadership to Ontario’s Masonic community and preserve the timeless Masonic initiatory system as a framework for all good men to transform their lives through the ancient and enduring tenets of brotherly love, relief and truth.” Are you that person? If so, now is the time to plan to be part of the team.

As we prepare for our Annual Communication of Grand Lodge on the third Wednesday of July and the Thursday following (July 18, 19, 2012), many of our Past Masters are considering being a candidate for the office of Grand Senior Warden, Grand Junior Warden, Grand Registrar, or a Member of the Board of General Purposes. If that is your intention, then your nomination application must be received by the Grand Secretary on or before April 1st. Because April 1st falls on a Sunday, the closing for 2012 nominations will be 4:00 p.m., Monday, April 2, 2012. Don’t test the system; get your applications in early. There are no exceptions. I strongly recommend prospective candidates familiarize themselves with Sections 36 to 41 inclusive, of the Book of Constitution (2011).

No Brother shall be eligible for office in Grand Lodge unless he has attained the rank of Past Master. Candidates, other than G.M., D.G.M. and D.D.G.M.s, are nominated, in writing on a prescribed form, by any member of Grand Lodge. The Nomination Form, which will have an attached passport-size photo of the candidate (colour preferred), must be signed by the nominator and the candidate.

Grand Lodge consists of its Grand Lodge Officers, its Past Grand Lodge Officers, Past Masters and the Masters and Wardens of all Lodges duly returned on the Grand Lodge register. Any Lodge which has neglected to deliver to the Grand Secretary its returns and payments to Grand Lodge on or before July 8, 2012, Masters and Wardens will not be able to vote at Grand Lodge, including voting for the elective Grand Lodge Offices and the Board of General Purposes. This includes proxy votes. Attention D.D.G.M.s - that is why you have been directed by Grand Lodge to ensure Lodges in your District have submitted their returns to the Grand Secretary.

All constituent Lodges in Ontario who attend our Annual Communication of Grand Lodge should have an opportunity to exercise their right and vote for their Grand Lodge Officers two of whom are the Grand Wardens and the Grand Registrar.

The office of Grand Warden is an elective Grand Lodge office for one year. Aspirants may be nominated by any member of Grand Lodge and submit that nomination to the Grand Secretary. The candidate receiving the majority of votes will be declared elected by the Grand Master. The Grand Wardens, whenever directed, shall attend the Grand Master and act as his Warden. Further, the Grand Wardens have an important role in the Ceremony of Constituting and Consecrating a Lodge, dedicating or rededicating a Cornerstone, Ceremonies of Amalgamation and Extinguishing the Lights of a Lodge. More importantly, the Grand Wardens are expected to know their Work, such as, Opening and Closing in all Three Degrees, calling from Labour to Refreshment and vice versa, opening and closing a Board of Installed Masters and/or Grand Lodge, together with, the Ritual Work of a Warden. I can assure you, when you attend a Lodge and sit in the chair, Lodge Junior and Senior Wardens will be watching you. You will need proficiency in the Mechanics of the Work and of our Ritual.

The nomination and the election process of the Grand Registrar is the same as the Grand Wardens, with an additional qualification. The applicant must comply with Section 50(b) and be in possession of a certificate of completion of the course for the prospective District Deputy Grand Master, as offered by the College of Freemasonry. This qualification relates to the duties of the Grand Registrar found in section 114: “The Grand Registrar may, at the pleasure and direction of the Grand Master, take charge of any District for which there is not a District Deputy Grand Master.” Therefore, the Grand Registrar must be familiar with the duties and responsibilities of a District Deputy Grand Master. The Grand Registrar will also visit and report on the activities of the Heritage Lodge.

So, what is next? If you have the energy, time and qualities, consider being part of your Grand Lodge team.

## ANCIENT CHARGES OF 1723

### VI. Of BEHAVIOUR.

#### 3. “BEHAVIOUR when BRETHREN meet WITHOUT STRANGERS, but not in a LODGE Formed.

You are to salute one another in a courteous Manner, as you will be instructed, calling each other Brother, freely giving mutual instruction as shall be thought expedient, without being ever seen or overheard, and without encroaching upon each other, or derogating from that Respect which is due to any Brother, were he not Mason: For though all Masons are as Brethren upon the same Level, yet Masonry takes no Honour from a man that he had before; nay, rather it adds to his Honour, especially if he has deserve well of the Brotherhood, who must give Honour to whom it is due, and avoid ill Manners.

#### 4. BEHAVIOUR in presence of Strangers NOT MASONS.

You shall be cautious in your Words and Carriage, that the most penetrating Stranger shall not be able to discover or find out what is not proper to be intimated, and sometimes you shall divert a Discourse, and manage it prudently for the Honour of the worshipful Fraternity.

#### 5. BEHAVIOUR at HOME, and in Your NEIGHBORHOOD.

You are to act as becomes a moral and wise Man; particularly not to let your Family, Friends and Neighbors know the Concern of the Lodge, &c., but wisely to consult your own Honour, and that of the ancient Brotherhood, for reasons not to be mention'd here You must also consult your Health, by not continuing together too late, or too long from Home, after Lodge Hours are past; and by avoiding of Gluttony or Drunkenness, that your Families be not neglected or injured, nor you disabled from working.”

## CELL PHONE ETIQUETTE

This article appeared in the **PROTOCOL & ETIQUETTE ESSENTIALS** Issue No. 16 - March

2012. The Grand Master sincerely hopes that you will take heed and act accordingly. He encourages every Worshipful Master to make an announcement at the beginning of each meeting regarding these devices.

“How did freemasonry ever get along without cell phones for our first 900 years? Rather nicely, actually.



The presence of electronic devices in our lodge rooms has, unfortunately, become very common. What is their place in lodge? Well, as long as: they don't ring; you don't check your e-mail; you don't send text messages; you don't use your browser and they don't contain excerpts from our rituals and ceremonies, they may have one use.

That use is for emergency calls only, (should such a need arise) – provided your phone is set to vibrate instead of ring.

The solemnity of our Degrees should never be disturbed by a ringing phone. You are doing a great disservice not only to the candidate, but also to every other brother in the room – most especially to the brother who is conducting ritual.

A ringing phone at a **Masonic Memorial Service** is also to be avoided. It can negate the favourable impact we work so hard to leave with the family and friends.

One thoughtless, discourteous act by a single brother can spoil the occasion for so many.

You may think no one else is aware that you are texting or e-mailing in lodge but rarely is such the case. You can quickly become a distraction.

Should a phone ring in lodge, it is completely within the Worshipful Master's authority to order the brother to leave the lodge room. It is up to the Master to decide whether or not to readmit that brother before the meeting ends.

Notes:

- Section 281 of our Constitution prohibits the reproduction of our ritual by any electronic means.
- Should a brother disturb the harmony of the lodge, Section 295 empowers the Master to order him to leave the lodge room.
- If there is the possibility of receiving an emergency call while at a lodge meeting, alert the Master beforehand. He MAY permit you to leave the lodge room “without ceremony” to answer such a call.”

## **GROUNDBREAKING REPORT ON THE FUTURE OF FREEMASONRY IN THE U.K.**

The Freemasons have today published a groundbreaking, independently commissioned report that sheds new light on Freemasonry, its role in society and its relevance today.

“The Future of Freemasonry” report is the first ever independent study conducted by a non-Masonic body, and was commissioned as part of the build-up to the United Grand Lodge of England’s tercentenary in 2017.

Produced by the highly respected Social Issues Research Centre (SIRC) in Oxford, the report suggests that, contrary to some misleading commentary, Freemasonry actually demonstrates genuine openness and transparency and it concludes that it is arguably more relevant today than ever before.

In particular, the report highlights that Freemasonry acts as a ‘constant’, providing members with a unique combination of friendship, belonging and structure, with many Masons saying they have made valuable lifelong friendships.

The report also highlights the importance that Freemasonry places on charitable giving, the part that many Freemasons play in their local communities and the central role of the family. As well as instilling in its members a moral and ethical approach to life – including thoughtfulness for others, kindness in the community, honesty in business, courtesy in society and fairness in all things – Freemasons are the largest charitable givers after the National Lottery, and also make major contributions to international disaster relief funds.

The role of ritual is shown to be an important part of Freemasonry for many members, with the report concluding that it provides both structure and familiarity, in just the same way as the normal rituals of daily life do for many people.

Alongside the report, the United Grand Lodge of England also commissioned a quantitative survey among non-Masons, which revealed a significant level of interest in the organisation.

Key findings include:

- While half of those questioned said they did not know what Freemasonry is all about, more than one in three (35%) were aware of its charitable role.

- Nearly half (49%) wanted to know more about Freemasonry, while a quarter of male respondents (26%) would consider joining. Of these, 68% were attracted to the idea of belonging to a group and making new friends and 58% would like to do more in the community.
- Of those men who would not consider becoming a Mason, the single biggest response (given by 40%) was the misconception that “it’s not for people like me”. (Freemasonry is actually open to all men regardless of race, colour, religion, political views or social or economic standing.)
- More than a third (37%) of all respondents said that, if they met someone they knew to be a Freemason, they would be hesitant to raise the subject with them, while a further 20% would definitely say nothing, wrongly believing Masons are not allowed to talk about their membership. (In reality, members are actively encouraged to talk about the organisation and the important contribution it makes to society.

Nigel Brown, who has been the Grand Secretary of the United Grand Lodge of England since 2007 and is leading the plans for the tercentenary celebrations, says: “The results of the research are encouraging, though we clearly still have some way to go to change people’s perceptions. This is just one step in our ongoing efforts to demonstrate our openness and transparency, and to inform people about the role we play in society.

“The tercentenary is a significant milestone for Freemasonry and while we’re keen to celebrate our first three hundred years, it’s also crucial that we look forward to ensure that we remain relevant and continue to grow our membership over the next three hundred.”

Peter Marsh, Co-director of SIRC, said: “The Future of Freemasonry” provides an insightful commentary, not just on the organisation, but also on modern society. Despite the many changes taking place – or perhaps because of them – our desire to be part of something and to help other people is undimmed. It’s here that Freemasonry has an important part to play.”

Nigel Brown concluded: “This report will form an important part of our discussions as to how best to ensure that Freemasonry continues to evolve and adapt to meet the needs of its members and also of wider society, while at the same time retaining the distinctive character and intrinsic values that have

attracted members for centuries and continue to appeal to people today.”

## **EXECUTIVE SUMMARY OF RESULTS**

### **Report of the Long Range Planning Committee on the 2011 Grand Lodge Ontario Survey**

#### **Why I Joined Masons**

##### **Top three reasons for joining Masonry**

1. Brotherhood – making new friends and acquaintances from all walks of life, every background and age group.
2. Self-improvement – becoming a better person.
3. Knowledge – finding out about the history and mysteries of Freemasonry.

##### **Least selected reasons for joining Masonry.**

1. Achievement – progressing through the offices.
2. Education – learning from peers and mentors by practicing ritual and making short speeches.
3. Charity – being able to contribute to deserving causes, both Masonic and non-Masonic.

#### **The Ritual**

78.9% of respondents rated the ritual in their lodges Excellent or good; only 4% rated the ritual poor or marginal.

#### **Lodges**

78.4% of respondents rated Lodge buildings Excellent or Good; 7.5% rated lodges poor or marginal.

#### **Member Retention**

44.4% of respondents believe their lodge is doing enough to retain quality members; 40.3% believe they are not.

#### **Lodge Viability and Sustainability**

59.9% of respondents believe their lodge is at serious or very serious risk of going dark; only 16.5% believe it is not an issue for their lodge.

#### **Attendance at Lodge Meetings**

71.9% of respondents attend regularly or frequently; 9.8% seldom attend and 4.7% pay their dues but don't attend.

#### **Future Planning at the Lodge Level**

40.3% of respondents are familiar with the future plan for their Lodge; 21.5% don't think their Lodge has a plan.

#### **Preparation of Candidates and the First Three Degrees**

52.9% of candidates were not provided with documents or other information to explain Masonry  
54.5% of initiates were not invited to an educational session that explained Masonry to them as Masons.  
83.2% were not invited to a brother to brother event before being made Master Masons.

71.9% were not invited to an information session that explained the Craft in Ontario or options for membership in other Masonic groups.

#### **The Masonic Journey**

42.9% of respondents are not members of concordant or affiliated Masonic organizations.

#### **Respondents by Rank**

E. A. 2.6%    F.C. 3.3%    M. M. 41.6%  
W.M. 33.6%    V. W. 9.1%    R. W./M. W. 9.8%

#### **Participation in the Craft**

46.0% of respondents have not been Masters of their lodge; 19.6% have been master of their lodges two or more times.

#### **Memorize the Ritual**

77.1% of respondents believe the ability to memorize the ritual should be a requirement to progress.

#### **Instruction for Candidates for EA, FC and MM**

70% of respondents believe there should be a programme that instructs candidates for each degree to prepare them for the ritual.

#### **Age of Masons**

Of those who responded:

- 4.2% are under 30    • 12.4% are 31-40
- 15.7% are 41-50    • 21.8% are 51-60
- 26.1% are 61-70    • 19.2% are over 70
- 0.6% chose not to indicate their age

#### **Membership in Masons**

55% of Masons in Ontario have been members for 20 years or less; 26.2% have been members for more than 30 years.

#### **Electronic Masonry**

Respondents were asked to indicate their willingness to use on-line functions if provided by Grand Lodge. The response was overwhelmingly positive. For the complete report, contact Grand Lodge at <http://www.grandlodge.on.ca> .

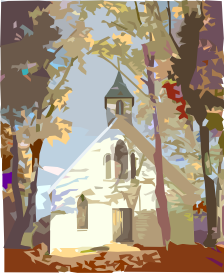
