
I made a fraternal visit to Meridian Lodge last November and witnessed a Master Mason Degree due to the W.M. and Secretary being out of the country the day of my official visit.

# “WHITE BALL ELECTS, BLACK BALL REJECTS.”

## Part I

This, or some similar statement, is usually made at a lodge prior to voting on the application of one who would be an initiate of Freemasonry.

The “secrecy of the ballot” and the universal (in this country) requirements that a ballot be taken to elect are two of the greatest bulwarks of the Fraternity. Occasionally both the secrecy and the unanimity may seem to work a hardship on a man apparently worthy of being taken by the hand as a brother; but no human institution is perfect, and no human being acts always according to the best that is in him. The occasional failure of the system to work complete justice may be laid to the individuals using it and not to the Fraternity.

“Harmony being the strength and support of all well regulated institutions, especially this of ours.” This phrase, or one similar, is familiar to all Masons. Harmony (oneness of mind, effort, ideas and ideals) is one of the foundations of Freemasonry.

Anything which interferes with harmony by so hurts the institution; therefore, it is essential that lodges have a harmonious membership; that no man be admitted to the Masonic home of any brother against his will. For this reason it is required that the names of applicants to a lodge be set before the entire membership, prior to a vote, that all may know that John Smith is to be balloted upon; that any who think him unfit timber for the lodge, or who have personal objections to entering into the sacred relation of brotherhood with him, may have the opportunity to say “No.”

The power thus put in the hands of the individual Master Mason is very great. No officer, not even the Grand Master, may inquire how we vote, or why we voted as we did. No Grand Master has the power to set aside the rejection of an applicant.

This rejection of an application does more than merely prevent the applicant from being given the degrees. It creates over the petitioner a lodge jurisdiction. He may not apply to another lodge for the degrees refused him by this one, without first securing from that lodge a waiver of jurisdiction. He may not again apply even to the lodge which rejected him until after a certain statutory period (usually six months). When his application is again received and brought up for ballot, the fact that he previously applied and was rejected is stated to the lodge. In other words, the casting of a black ball not only rejects for the degrees, but puts a certain disability upon the applicant which he is powerless to remove.

The brother who casts a ballot, then, upon an applicant, wields a tremendous power. Like most powers, it can be used well or ill. It may work harm, or good, not only upon him upon whom it is used, but to him who uses it. Unlike many great powers put into the hands of men, however, this one is not subject to review or control by any human agency. No king, prince, potentate; no law, custom or regulation; no Masonic brother or officer, can interfere with the individual's use of this power.

For no one knows who uses the black ball. No one knows why a black ball is cast. The individual brother and his God alone know. The very absence of any responsibility to man or authority is one of the reasons why the power should be used with intelligence, and only when, after solemn self-inquiry, the reason behind its use is found to be Masonic.

Any one can think of a hundred reasons why black balls are cast. An office associate, for example, wants to be a Mason. He applies to our lodge. As far as the investigating committee can ascertain, he is a good man, honest, pays his debts, is a church member, a hard worker. But we have heard him repeat, to us and to others, matters which we know were

given to him in confidence. We have learned to distrust his discretion. We don't believe that a promise means much to him. It may be, of course, that a Masonic obligation would be kept. But we are not sure. How would you vote?

A certain man is our personal enemy. The quarrel between us may have nothing to do with

right and wrong; it may be the result merely of a life time of antagonism. He applies to our lodge. Our lodge is our Masonic home. We would not want this man in our family home; we do not think we will be happy with him in our Masonic home. Would you use your right to vote against him?

These, and a thousand other good reasons, are all proper ones for the casting of a black ball. If the lodge might suffer, if we might suffer, if we know that our absent brother would suffer from the applicant being elected, we have the best of reasons for seeing that he is rejected. Such use of our power is proper, Masonic, ethical, wise, just.

But there is another side of the shield. Unfortunately, no hard and fast rule can be laid down. There is no way to explain “this is a good reason, but that is not a good reason” for casting a black ball. Each of us has to judge the reason for himself. Yet some suggestions may be given. (Part II in April 2013)

### **A Masonic Minute** *The Canadian Maple Leaf Flag*

The Canadian Maple Leaf Flag was adopted by Parliament on December 16, 1964, **officially proclaimed by Her Majesty Queen Elizabeth II, and inaugurated on February 15, 1965**, now observed in Canada as National Flag Day. The adoption of the distinctive design emerged from much debate, led by the Leader of the Opposition, the Right Honourable Bro. John George Diefenbaker.



Our distinguished Brother, the Honourable John Ross Matheson, at the time the Parliamentary Secretary to the Prime Minister, Lester B. Pearson, by adroit negotiations with the opposing parties, was instrumental in the final resolution of the debate. Bro. Matheson is also responsible for the creation of the Order of Canada.

Bro. Matheson was initiated in Queen's Lodge No. 578, Kingston, in 1940 on the night before he was deployed with his regiment for active service in World War Two. He is the recipient of the William Mercer Wilson Medal for Meritorious Service, a 33<sup>rd</sup> degree Scottish Rite Mason, and a member of the Royal Order of Scotland. On November 13, 2010, Bro. Matheson was presented with the Long Service Award – 70 Years a Freemason in a ceremony attended by the Speaker of the House, Members of both the Federal Parliament and the Ontario Legislature, together with a host of friends and family.

The words from the Sacred Writings in the Book of Revelation, "*The leaves of the tree were for the healing of the nations*" were quoted to describe the distinctive design of the distinctive design of the Maple Leaf Flag. In a speech given to the Supreme Council of the Ancient and Accepted Scottish Rite, Bro. Matheson said: "*Our symbolism must need affirm spiritual values. It conveys a message of noble expectations for humanity, of our Masonic hope for an even 'better country.'* Each of us, like the Flag, represents Canada. This nation can be no worthier than what we imagine and will it to be."

When M. W. Bro. Donald H. Mumby was the Director of the R.C.M.P. Degree Team, this Charge to the Flag was given as part of the ceremony:

"I present our Flag, our symbol of Unity and Sovereignty, between bars of red on a field of white; it blazons forth in its full Autumnal glory the **Canadian Maple Leaf**, whose points represent the Provinces and Territories, which comprise our great Dominion.

To Freemasons –the red symbolizes the dauntless courage of our forefathers, which we strive to emulate; the white, that blameless purity of life and conduct to which we aspire, and the points, the eleven knightly virtues, of which Patriotism is the greatest, and to which we are ever dedicated,

And finally, it inspires in us a reverence to Him, to whom we fervently pray.

**God Save the Queen, and Heaven bless The Maple Leaf Forever."**

## Blood Donors Update

The Blood Donors Committee is glad to report several areas in which our contribution to the Canadian Blood Services has improved during the course of this 2012-2013 Masonic year.



The number of units collected in clinics sponsored by our District and where Hamilton Masonic District C Volunteers have manned

the hospitality Station is at 1004 as of Feb. 14, 2013, with four clinics still remaining for this 2012-2013 fiscal year of the Canadian Blood Services.

Out of thirteen Lodges in the District, we have 12 Lodges which have sponsored clinics or assisted with the manning of the hospitality stations.

Something new this year is that a number of Lodges have sponsored more than one clinic each: Buchanan Lodge, No. 550 sponsored three clinics this year, and Meridian Lodge, No. 687 sponsored two clinics.

Lodges are starting to assume permanent responsibility for the manning of the hospitality stations. Again, Buchanan Lodge, No. 550 at some of the clinics at the Convention Centre and Meridian Lodge, No. 687 at all of the clinics at Paramount.

Our commitment with CBS continues to increase: this year; our District will have sponsored or volunteered at 22 clinics. The Canadian Blood Services realizes that they can count on us for assistance and we are very proud to be able to assist them.

The Hamilton Masonic District C thanks all the Lodges and individual volunteers who have helped this year. The campaign of collecting blood is a noble campaign due to the importance of having a steady supply of this precious substance available to the community.

David was born in Blackburn, Lancashire, England, where he received his early education. Before he could proceed to university to study medicine, which was his father's profession, World War II intervened. He had been commissioned in 1937 in a reserve battalion of The East Lancashire Regiment. When his Regiment was mobilized in 1939, 2<sup>nd</sup> Lieutenant Bradley began a seven-year-period of Active Service which took him to India and to operations as an Infantry Officer in the Burmese jungle. Later service included appointments as a General Staff Officer and as an Intelligence Officer. Following demobilization in 1946, he was awarded the coveted Territorial Decoration.

Upon moving to Canada and taking up residence in Toronto, he resumed his interrupted formal education by studying political science at York University, Toronto, and also by undertaking off-campus courses in business administration at Queen's University, Kingston. He graduated from York University with a B.A. degree. Following several positions in financial management of companies in the construction industry he was appointed Director and Corporate Secretary of a conglomerate having extensive holdings in manufacturing, construction and management consulting services. Another position in his business career was that of Assistant to the General Manager of the University of Toronto Clinic at Sunnybrook Hospital. Upon retirement, he was elected to Life Membership in the Medical Group International Association.

M. W. Bro. Bradley was initiated in Queen City Lodge No. 552, Toronto, in 1954. His active business career occasioned the family to change residence location to a number of areas in the Toronto Region; thereby he had need to affiliate with Rising Sun Lodge No. 129 in Aurora, then after returning to Toronto, he affiliated with Doric Lodge No. 316, becoming Worshipful Master in 1968. He served, during 1973-74, as the District Deputy Grand Master of Toronto District 3 and became a member of the Board of General Purposes in 1980. He was a member of the Advisory Committee of the Board from 1984 to 1987, serving as Chairman during his last year. As a member of the Committee on Masonic Education from 1980, he undertook a wide variety of duties. Among these were Curriculum Chairman for the Correspondence Course offered by Grand Lodge and Editor of the Newsletter 1981-87. In addition he was Chairman of the Committee on Annual Seminars from 1982 to 1984 and was Chairman of Blood Donors' committee in 1985. He was elected Deputy Grand Master in 1987. *"He did the good act, not for himself, but for the cause of good."*


